

## Carlton in Lindrick Parish Council

A meeting of the Parish Council was held at the Civic Centre, Long Lane, Carlton in Lindrick, Worksop, on Tuesday 10<sup>th</sup> January 2017.

Present: Councillor C. Smith (Chairman) Councillors E. Banks, K. Broad, C. Connolly, S. Jackson, S. Ludden, W. Murdoch, P. Nicholson and A. Williams.

County Councillor A. Rhodes, District Councillor R. Carrington-Wilde and Peter Goulding (Parish Clerk) were in attendance.

Apologies for absence were received from Councillors L. Billau, B & V Bowles, M. Pepper, S. Scotthorne and District Councillor D. Pidwell.

Prior to commencement of Council's official business, the Chairman announced that in accordance with the Openness of Local Government Bodies Regulations, audio/visual recording and photography at Council meetings is permitted in accordance with the Council's protocol "Filming of Public Meetings".

### 72. POLICE/PUBLIC PARTICIPATION

Councillor P. Nicholson submitted thanks on behalf of Andrew Bell who attended the recently held reception for local volunteers.

### 73. MINUTES

RESOLVED that the minutes of the meeting held on the 13<sup>th</sup> December 2016 be approved.

### 74. NOTTS COUNTY COUNCIL ISSUES

#### a) Civic Centre Signage

RESOLVED that the Highways Managers response be noted and his views be obtained on costings being contributed to by Parish council in order to expedite the process

#### b) Damaged Village Entry Sign

The Clerk reported on costings being obtained for replacement of the sign. It is intended to pursue the cost of replacement via the vehicle owner responsible for the damage.

### 75. BASSETLAW DISTRICT COUNCIL ISSUES

#### i) Telephone Mast – Long Lane

Despite objections raised by the Parish Council and local District Council Representatives this proposal has been approved by the District Council Planning Department.

Local District Members had requested that the application be considered at member level but the decision was made via delegated authority. Observations have been received from local community members on the inappropriate location approved for this development which is now in place.

RESOLVED that 1) the Clerk write to the Local MP confirming this Council's original observations submitted to both the applicant and the District Council and registering this

Council's dissatisfaction with the process applied in consideration of the Planning Application.

2) the Clerk also write to the District Council Chief Executive expressing deep disappointment on the procedure which led to approval of the Planning Application.

ii) Blyth Road/Hundred Acre Lane Caravan Site

Councillor Carrington-Wilde agreed to investigate concerns on the access to this site and the damage being caused to grass verges and road surfaces.

iii) Football Grant Eligibility

Councillor Carrington-Wilde reported on land ownership eligibility for grants enquired about at a previous meeting but said that other funding opportunities were being investigated.

76. PAYMENT OF ACCOUNTS

RESOLVED that the payments schedule dated 10<sup>th</sup> January 2017 be approved.

77. CARLTON NEWSLETTER GRANT APPLICATION

Members considered the grant application received from the Carlton News Editorial Panel. The application detailed the Panels current financial arrangements which secure the current quality levels applied to the production. Members discussed the excellent service and support provided by the Newsletter Group and referred particularly to the consultation and communication service enjoyed by the Parish Council and other local organisations.

RESOLVED that the grant aid of £1,000 be approved for the Carlton in Lindrick Newsletter Group.

78. COUNCIL TAX REFERENDUM PRINCIPLES

Members had before them a notification from the Association of Local Councils that the principles have not been extended to Parish Council's for the year 2017/2018. Levels of precepts set by Parish Councils will be kept under review but capping principals do not currently apply.

RESOLVED that the report/information be noted.

79. PLANNING APPLICATIONS

16/01771/FUL – Lilac Lodge, Woodhouse Lane – Erect Single Storey Building for New Cat Boarding Establishment

Whilst not objecting to this proposal the Parish Council feels that the views of the County Council Highway Department should be obtained on the suitability of the highway access to the premises and any requirements necessary for the potential of increased traffic including car park facilities.
