

Carlton in Lindrick Parish Council

A meeting of the Parish Council was held at the Civic Centre, Long Lane, Carlton in Lindrick, Worksop, S81 9AP on Tuesday 10th November 2015.

Present: Councillor C. Smith (Chairman) Councillors, T. Banks, L. Billau, V. Bowles, K. Broad, R. Dyas-Elliott, W. Murdoch and A. Williams.

Helen Brown (Administration Assistant) District Councillor R. Carrington-Wilde and Maurice Stokes (Civic Centre Trustee) were in attendance.

Apologies for absence were received from Councillors B. Bowles, C. Connolly, S. Jackson, M. Mills, S. Scotthorne and PC Goulding (Parish Clerk).

Prior to commencement of Council's official business, the Chairman announced that in accordance with the Openness of Local Government Bodies Regulations, audio/visual recording and photography at Council meetings is permitted in accordance with the Council's protocol "Filming of Public Meetings".

48. POLICE/PUBLIC PARTICIPATION

Public

The meeting was attended by a resident of Dadley Road who is encountering continuing problems following the establishment of play equipment at the Beckett Avenue Play Area. The resident who has made earlier representation on the problem explained he had met with District Councillors and the problems are to be monitored over 6 months.

District Councillor Carrington-Wilde explained again the measures that had been taken to address the problems and he would find out more and inform Councillor Scotthorne.

Mr Dearnay reported to the Parish Council on the planting of the Christmas tree on library ground and that a lighting ceremony with stalls and singing will take place at the library on the 5th December 2015 and members of the council are invited.

Police

Cllr Bowles requested the police be asked to look at the Highway Maintenance vehicle parked dangerously on The Baulk. Councillor Billau informed members of correspondence received from the County Council including inconsiderate parking cards.

Members considered a report received from the police on local policing issues.

50. MINUTES

1) Remembrance Day arrangements

It was confirmed that a letter of thanks had been forwarded to the Police for their involvement, in addition information was received on the financial contribution collected for the British legion.

51. Trustees Civic Centre Report

Councillor Smith thanked Maurice Stokes for his continued support to the Civic Centre.

Maurice updated members on maintenance work carried out and went on to explain the current problems experienced at the Centre. Roof and floor works need to be undertaken and the Civic Centre hope to apply for grants to cover the costs. The current financial situation was reported and a request for an additional £2,000 was made to cover mandatory living wage implementation in April 2016. Maurice thanked the Parish Council for its continued support. Councillor Smith responded

with the Parish Council's thanks to the Centre Managing Trustees and staff in providing a good quality Community Facility which the Parish Council is happy to continue to support.

52. NOTTS COUNTY COUNCIL ISSUES

Councillor Smith reported on the recent inspection of drains in the village with Ian Parker (Notts County Council Highways) a new scheme is to be devised and budgeted for. Drains outside the precinct on Long Lane are to be flushed to cure the problem.

53. BASSETLAW DISTRICT COUNCIL ISSUES

Councillor Carrington-Wilde updated members on the proposed Firbeck Development. It has been established the road off the A60 is not adequate, Bassetlaw District Council have applied for funding from County Council.

Councillor Smith advised the importance of this site and it being supported by the Neighbourhood Plan and asked Councillor Carrington-Wilde to report and update.

Councillor Murdock reported on dog fouling on the play area behind the Civic Centre and it was requested the dog warden be asked to attend the area. Councillor Carrington-Wilde agreed to speak to the officer.

54. CHEQUES ISSUED

RESOLVED that the list of cheques issued be noted and approved.

55. BURIAL GROUND

The Administration Assistant updated members on the Clerks progress at the A60 site. Options are being prepared and Peter will report to the budget meeting about the project. At the Hundred Acre Lane site Solicitors and Kenay Rashed are dealing with some of the conditions in the planning approval and Kenay will be reporting to be Burial Ground Sub-Committee over the next few weeks. Discussions were had on the possibility of a crematorium on the Hundred Acre Lane site and it being a possible source of income.

56. PLANNING ISSUES

Neighbourhood Plan

Councillor V Bowles updated members on the meeting held on the 6th November and advised it was a very productive meeting. A breakfast meeting to liaise with local businesses has been organised for the 24th November 7am – 9.30am. Members were also informed of the grants received.
