

CARLTON IN LINDRICK PARISH COUNCIL

A meeting of the Parish Council was held at the Civic Centre, Oakham Drive, Carlton in Lindrick on Tuesday 10th June 2025.

Due to the delayed arrival of the Chair, Councillor S. Jackson (Vice-Chair) commenced proceedings.

Members considered the statistical report presented by PCSO Parker for May 2025. In addition, Councillor Scotthorne recorded his and the Council's thanks for work contributed at the Youth Centre on Anti-Social Behaviour and helpful guidance received by young participants.

17. NOTTS COUNTY COUNCIL ISSUES

Councillor Kev Dale

The Chair and Members extended a welcome to Councillor Dale who was in attendance at his first Parish Council meeting following his recent election as County Councillor.

In accepting the welcome, Councillor Dale indicated his intention to represent the Parish and its community on issues relevant to the County Council and Councillor Dale informed members of his contact details.

Councillor Dale was informed of ongoing highway problems with the road surface at Greenway and of problems faced by pedestrians being obstructed through overhanging hedges on private properties. Members were reminded that other highway surfacing repairs are to be undertaken by the County Council in the current financial year.

19. BASSETLAW DISTRICT COUNCIL ISSUES

District Councillors reported on consultations on Car Parking charges being undertaken and on events at Kings Park, Retford. Sources of Government Funding for rural areas were highlighted, and members were reminded of community events continuing at Cleveland Close Community Centre.

The District Council is commencing a “Call for Sites” exercise to determine potential sites for housing development in the District.

Members were assured that only the sites in the Parish Neighbourhood Plan which are alongside the A60 (10 housing units) and the possible development of the James Hince Court Site would be included from our own Parish.

Members were also informed of the County Council’s involvement in the anticipated planning application for a “Solar Panel Farm” to be established in the Parish.
