

Carlton in Lindrick Parish Council

A meeting of the Parish Council was held at the Carlton in Lindrick Civic Centre, Long Lane, Carlton in Lindrick, Worksop, on Tuesday 11th June 2019.

Prior to commencement of Council's official business, the Chairman announced that in accordance with the Openness of Local Government Bodies Regulations, audio/visual recording and photography at Council meetings is permitted in accordance with the Council's protocol "Filming of Public Meetings".

27. PLANNING ISSUES

19/00595/FUL – Land east of Doncaster Road, Costhorpe – Construct temporary compound with associated materials store, car parking and 4 portacabins. The temporary compound will be required until April 2023.

The Parish Council has no objections subject to the area being returned to its original condition upon expiry of the temporary arrangements.

19/00671/CAT – Kingston House, Greenway – Works to trees in a conservation area. T1 sycamore. Crown reduction of 2 metres and canopy reduction by 1 metre T2 sycamore. The Parish Council has no objection subject to any observation made by District Council tree advisers and the Conservation Officer.
