

Carlton in Lindrick Parish Council

28. EXTERNAL WORKS – CARLTON YOUTH CENTRE

On behalf of the Youth Centre Management Committee Councillor Sandra Jackson presented proposals for external improvement works to be undertaken at the Youth Centre. The landscaping proposal which includes some ornamental and decorative brickwork will be undertaken by trained students from the North Notts College under appropriate supervision. The project will be a "child friendly" facility and will give students an opportunity to implement newly acquired skills. The project will be governed by college Health and Safety Policies and subject to appropriate Risk Assessment Guidelines. There will be no costs allocated to the Parish Council.

Members commented on the value of the project not only in terms of property improvement but as a good example of Joint Working arrangements between the Notts County Council, the North Notts College and the Parish Council.

17/0079/FUL – BDC – Gateway Community Centre -24-28 Sycamore Road – The Parish Council wishes to support this application

17/00777/FUL – PCG Developments – Former garages at Hawthorn Way – The Parish Council wishes to support this application

17/00853/FUL – Mr P Thomas - 2 Long Lane - The Parish Council has no objection to this proposal providing the views of occupiers of neighbouring properties are considered.

17/00683/HSE – Mr S Tomlinson – Clipstone House – The Parish Council has no objection to this proposal providing conditions are imposed which are applicable to the site location in the conservation area.

17/00828/OUT – Mr P Parra – 6 Doncaster Road – The Parish Council wishes to object to this proposal on the following grounds:-

- i) the development is located in what constitutes a large rear garden area to the existing property.
- ii) approval of the development would result in the access and egress of traffic being increased on a busy A60 Highway which already has two busy junctions within close proximity.
- iii) approval of the development would set a precedent for decisions on similar properties with large garden areas at the rear of existing domestic properties.
