A meeting of the Parish Council was held at the Civic Centre, Long Lane, Carlton in Lindrick, Worksop, on Tuesday 13th December 2016.

65. MINUTES

RESOLVED that the minutes of the meeting held on the 8th November 2016 be approved.

66. DECLARATIONS OF INTEREST

67. NOTTS COUNTY COUNCIL ISSUES

a) Letter of thanks

Members noted a letter of thanks received from Amanda Fenoughty following action taken by the County Council on a number of highway issues.

b) The Highways Manager has responded to request for a barrier to be erected adjacent to the narrow pavement on the A60 Highway near to "Casio's". Alternative proposals are being investigated.

c) County Councillor Rhodes indicated his support for a funding application under the County Council's "Supporting Local Communities Fund" for improvement work at the Civic Centre. In addition, Councillor Rhodes reported on recent financial application support given to the Youth Centre and to the Luncheon Club.

Members were also informed that Councillor Rhodes is a recently appointed Governor at the Kingston Park Academy and that Councillor S. Scotthorne has also been appointed.

2) the contributions made by Councillor Rhodes to local organisations be noted with thanks

68. BASSETLAW DISTRICT COUNCIL ISSUES

Smoking in Children's Play Areas

Members considered proposals being made by the District Council for a voluntary ban on smoking in children's play parks.

Whilst there would be no legal enforcement the District Council would be willing to provide signs to be placed in and around play areas highlighting that smoking in that area was not allowed.
