

## Carlton in Lindrick Parish Council

A meeting of the Parish Council was held at the Carlton in Lindrick Civic Centre, Long Lane, Carlton in Lindrick, Worksop, on Tuesday 13<sup>th</sup> July 2021.

County Councillor Callum Bailey, District Councillors R. Carrington-Wilde D. Pidwell and Peter Goulding (Parish Clerk) were in attendance.

Apologies for absence were received from Councillors B & V Bowles, S. Scotthorne and Police representatives.

Prior to commencement of Council's official business, the Chairman announced that in accordance with the Openness of Local Government Bodies Regulations, audio/visual recording and photography at Council meetings is permitted in accordance with the Council's protocol "Filming of Public Meetings".

### **10. PUBLIC PARTICIPATION.**

Representatives of the Northern Soul Group were present to discuss issues relating to bookings for events at the Civic Centre with particular reference to a 'Charity Event' they proposed to arrange in September 2021.

The Clerk reported on the Council's current views of Covid's ongoing effect on indoor mass gathering events and on measures still being recommended by Central Government.

The representatives were also advised that issues on provision of bar facilities at the Centre along with event bookings remained within the remit of the Civic Centre Managing Trustees and the Centre Manager.

Following discussion it was suggested by the Chairman that the representatives advise the Manager and Trustees of detailed risk assessment measures which would be implemented for the event along with financial proposals for the raising of charity funds and that any further consideration of the application be undertaken by the Manager and Trustees.

### **12 MINUTES**

RESOLVED the minutes of the Annual meeting of the Parish Council held on the 18<sup>th</sup> May 2021 be approved.

### **13. NOTTS COUNTY COUNCIL ISSUES**

#### **i) James Hince Court site**

The Clerk reported on further correspondence with County Council officers who currently advise that there is no more 'feedback' on the development of the site other than demolition arrangements which are scheduled for September or October 2021.

County Councillor Bailey confirmed the current status of proposals.

ii) Bassetlaw Local Plan – Education

Discussions continued on concerns relating to school place provisions to accommodate additional needs arising from developments included in the Plan proposals. Councillor Bailey is discussing proposals intended with the County Education Department and County advice was considered during the plan preparation which has resulted in proposals for additional secondary school places along with new school provision on the proposed Peaks Hill Farm Development.

Councillor Bailey also referred to the formula used by the County in determining school provision.

iii) Other Issues

Councillor Bailey agreed updates on the following:-

- a) Reflective signage at Owday Lane
- b) Box markings at Greenway
- c) Road surface at Greenway
- d) Sign visibility on Owday Lane bends
- e) Further work on hedge obstructions near to Wrights Butchers, Greenway

14. BASSETLAW DISTRICT COUNCIL ISSUES

Councillor Carrington-Wilde made supportive comment on his continued involvement with the Parish Council and reported on traffic speeding measurers being monitored at Tinkers Hill. A continuing police involvement is being adopted. Members expressed their thanks at this issue being addressed.

Councillor Pidwell commented on progress relating to the Firbeck Pit Site development and on the temporary need to close the cricket ground access.

15. CIVIC CENTRE/YOUTH CENTRE

The Clerk reported on use of buildings in a progressive return to some normality following covid vaccine measures. Members agreed the necessity of observing some caution for the time being and that the situation be reviewed at the next meeting in September 2021.

16. KING GEORGE V PLAYING FIELD/POND

The Clerk reported on informal discussions held with representatives of the Sherwood Ranger Football Club. The Club wishes to use facilities at the King George V Football pitch for the coming season and have given assurances relating to problems encountered with previous adult usage. The District Council has given assurances that the club can return to Costhorpe should the usage cause problems in the neighbourhood.

RESOLVED that usage of the football pitch by the Sherwood Ranger Football Club be approved and monitored by the Council for continued use.

17. PAYMENT OF ACCOUNTS

RESOLVED that the payments schedule for payments from July to 6<sup>th</sup> September 2021 2021 be noted and approved.
