

## Carlton in Lindrick Parish Council

A meeting of the Parish Council was held at the Civic Centre, Long Lane, Carlton in Lindrick, Worksop, S81 9AP on Tuesday 14<sup>th</sup> June 2016.

Apologies for absence were received from Councillors L. Billau B Bowles, Mark Pepper, C. Smith, A. Williams, District Councillors D. Pidwell, R. Carrington-Wilde and County Councillor A. Rhodes.

Prior to commencement of Council's official business, the Chairman announced that in accordance with the Openness of Local Government Bodies Regulations, audio/visual recording and photography at Council meetings is permitted in accordance with the Council's protocol "Filming of Public Meetings".

### 12. DEVOLUTION FOR SHEFFIELD CITY REGION

The Chairman welcomed to the meeting Councillor Simon Greaves, Leader Bassetlaw District Council. Councillor Greaves undertook a presentation on the proposals for Bassetlaw to become a constituent member of the Sheffield City Region and spoke on the perceived economic advantages of such membership.

Councillor Greaves indicated that the devolution process was at an advance stage and that discussions on resources being made available to the District were in progress. One of the current priorities is funding proposals for infrastructure work needed for the Costthorpe development. Councillors Greaves indicated that there are no current proposals for a change in local authority services.
