A Meeting of the Parish Council was held at the Carlton in Lindrick Civic Centre, Long Lane, Carlton in Lindrick, Worksop, on Tuesday 8th January 2019.

78. MINUTES

RESOLVED that the minutes of the meeting held on the 11th December 2018 be approved with the inclusion of apologies from Councillor Warren Murdoch.

79. NOTTS COUNTY COUNCIL ISSUES

County Councillor Rhodes referred to the current postponement of the County Unitary Authority proposal and reported also on his discussions with the Carlton representatives of the Worksop Live at Home Scheme.

The Clerk referred to a grant application to be discussed later on the agenda.

80. BASSETLAW DISTRICT COUNCIL ISSUES

i) Planning Application – 18/01148/FUL Lane East of Doncaster Road

This Planning Application is to be considered by the District Council Planning Committee on the 9th January 2019. Members had before then the Planning Officers report along with draft proposals for comment to be made at the Committee meeting by Councillor Val Bowles on behalf of the Neighbourhood Plan Steering Group and Councillor Lynne Billau on behalf of the Parish Council. District Councillor Robin Carrington-Wilde informed members of comments which he also would be making.

Members indicated support for the observations to be made with the inclusion of a comment on the lack of 2 bedroom affordable housing for sale.

83. WORKSOP LIVE AT HOME SCHEME, DADLEY ROAD, CARLTON IN LINDRICK

Members considered an application received from the above organisation relating to financial difficulties being faced as a result of cut backs in financial support. Particular difficulties are being faced with funding needed to support travel costs. Currently the organisation assists 129 elderly/isolated members of the community providing lunch club activities, days out, information and signposting along with ongoing support addressing other problems.

Members considered the current budget for grant applications and it was:

RESOLVED that

- 1) a grant of £500 be made
- 2) further assistance be considered at the March 2019 meeting
- 3) the Clerk be authorised to discuss the transport issues with the applicant with a view to determining any assistance which might be possible through the availability of the minibus at the Youth Centre
- 4) the applicant be advised to seek assistance from 'Big Local'

84. BURIAL GROUND – HUNDRED ACRE LANE

The Contract is proceeding in accordance with the programme.

Members were informed that a specification has been received from VIA for the provision of pedestrian access from the Village to the Burial Ground site. The specification is of a high standard for limited pedestrian use and is considered excessive by the Council's contract supervisor. Attempts are being made to revise the planning condition relating to this part of the Contract.
