

## Carlton in Lindrick Parish Council

A meeting of the Parish Council was held at the Carlton in Lindrick Civic Centre, Long Lane, Carlton in Lindrick, Worksop, on Tuesday 8<sup>th</sup> March 2022.

County Councillor Callum Bailey, District Councillor Carrington-Wilde and Peter Goulding (Parish Clerk) were in attendance.

Apologies for absence were received from Councillors L. Goulding, N. Gray and District Councillor D. Pidwell.

Prior to commencement of Council's official business, the Chairman announced that in accordance with the Openness of Local Government Bodies Regulations, audio/visual recording and photography at Council meetings is permitted in accordance with the Council's protocol "Filming of Public Meetings"

The Chairman extended a welcome to members of the public in attendance.

### 43. MINUTES

### 44. NOTTS COUNTY COUNCIL ISSUES

Council Councillor Bailey reported on a number of issues including budget proposals for road repairs and a revised repair programme. The request for renewed yellow road markings at the entrance to Greenway is being pursued. Requests will continue for bollard repairs at Blyth Road/Hundred Acre Lane. There was further discussion on the continuing importance of ensuring monitoring measures to the school bus service.

45. BASSETLAW DISTRICT COUNCIL ISSUES

Councillor Robin Carrington Wilde reported on the use of mobile speed monitoring equipment in Oxford Road, maintenance work on damaged grassed areas in Lawn Road and liaison between the police on anti social behaviour issues at Oxford Road and Beckett Avenue.

In addition Councillor Wilde indicated that the District Council is to review District Ward boundaries and member representation within the boundaries. Councillor Val Bowles requested that action be taken on random placard and poster signage which is on the increase. Particular reference was made to regular contraventions near to our own War Memorial area and other sites outside the Parish.

Councillor Scotthorne agreed to obtain information on consultations currently undertaken on retrospective planning applications.

The Clerk agreed to follow up on comments made by Councillor Connolly on obstructive growth of the King George V Playing Field.

46. PAYMENT OF ACCOUNTS

RESOLVED that the payment of accounts schedule dates 28<sup>th</sup> February 2022 be noted and approved.

47. GRANT APPLICATIONS

Members gave consideration to current applications received from Carlton New and from the 1<sup>st</sup> Carlton in Lindrick Scout Group. Members also considered current budgetary provision for grants to local organisations and it was:-

48. YOUTH CENTRE MINIBUS

Councillor Scotthorne reported that the minibus had been determined as being beyond economical repair. Use of a District wide mini bus vehicle is being negotiated.
