

Carlton in Lindrick Parish Council

A meeting of the Parish Council was held at the Civic Centre, Long Lane, Carlton in Lindrick, Worksop, S81 9AP on Tuesday 8th September 2015.

Present: Councillor C. Smith (Chairman) Councillors, T. Banks, B. Bowles, V. Bowles, K. Broad, C. Connolly, R. Dyas-Elliott, S. Jackson, M. Mills, W. Murdoch, and A. Williams.

PC Goulding (Parish Clerk), County Councillor A. Rhodes and District Councillor D. Pidwell were in attendance.

Apologies for absence were received from Councillors L. Billau, P. Nicholson, M. Pepper, S. Scotthorne and District Councillor R. Carrington Wilde.

Prior to commencement of Council's official business, the Chairman announced that in accordance with the Openness of Local Government Bodies Regulations, audio/visual recording and photography at Council meetings is permitted in accordance with the Council's protocol "Filming of Public Meetings".

28. NORTH NOTTS FIRST RESPONDERS

The Chairman welcomed Mr Robinson of North Notts First Responders. Mr Robinson was present to give a presentation to the Council on work undertaken by his organisation in North Nottinghamshire including the Carlton Area.

Mr Robinson is Lead Coordinator in the area and there are 12 emergency responders for the Bassetlaw Area. During the current year over 300 calls have been made to date for the organisations trained volunteers to attend emergency call outs and attendances have been made on 12 or 13 occasions in Carlton. Mr Robinson described the conditions faced by the responders who are regularly first on the scene giving help and assistance.

Mr Robinson thanked the Council for its recent financial support for the organisation and was informed that the Council will consider additional help at the end of the financial year when the Council's balances are determined.

30. MINUTES

RESOLVED that the minutes of the meeting held on the 14th July 2015 be approved with the inclusion of the attendance of Councillor Connolly.

31. NOTTS COUNTY COUNCIL ISSUES

Councillor Rhodes reported on funding which has been allocated for a new play area in Lime tree Avenue. The scheme will be undertaken during the current month and completion is anticipated within a few weeks. A sum of £44,000 has been approved for the work. In addition a grant of £500 has been allocated for activities at Kingston Park School.

Council Rhodes agreed to investigate the following issues:-

- a) Highway drainage outside Kingston School
- b) Potential for double yellow lines in parts of Low Street
- c) Parking problem being created by Highways vehicle

RESOLVED that Councillor Rhodes be thanked for his reports on funding for local activities.

32. BASSETLAW DISTRICT COUNCIL ISSUES

i) Public Spaces Protection Order

Members considered the order which came into force on the 1st September 2015 for a maximum period of 3 years. The protection order is in respect of Dog Control and areas within the Parish are included. Various activities undertaken by the District Council in support of the order were included in a letter received from the Environmental Health Team Leader.

ii) Stray Dogs

RESOLVED that the Clerk ascertain from the District Council Health Department the process to be adopted by members of the public identifying the presence of stray dogs.

RESOLVED that the minutes of the Finance and Risk Assessment Sub Committee and the Environmental Working Party Meeting held on the 29th July 2015 and the Planning Sub-Committee held on the 7th August 2015 be approved.

34. FINANCIAL ISSUES

i) Grant Application

Members considered a letter from A & S Henry detailing the progress of the Free 24 Fit Boot Camp. Attendances at the camp activities are increasing and Health Benefits continue to be identified. The organisers are requesting the Council's continued support in providing accommodation at the Civic Centre.

RESOLVED that

- 2) the Council approve the continued sponsoring of the organisation to the 31st March 2016
- 3) the Council review its role when the grants budget is prepared for 2016/17

RESOLVED that the Parish Council grant aid the Charity in the sum of £105.74 for the renewal of Public Liability Insurance.

The Clerk has been notified by the Council's external auditor that the Accounts for 2014/15 have been approved and there are no issues to be brought to the attention of the Council.
