Youth Centre Community Bus

The Clerk informed members that the Youth Centre Management Committee had entered into an Asset Transfer Agreement with Notts County Council for Young People's Services Vehicle. The Agreement has been examined by the Council's Solicitors who has endorsed the purpose of the Asset Transfer.

Councillor Scotthorne reported that in addition to Youth purpose the community bus will be made available for use by other community organisations and a process was in place for driver's eligibility to voluntarily drive the vehicle are in place. It is hoped that the initial cost of annual insurance will be met by the "Big Local" and the Council is requested to support the initiative.
