A meeting of the Parish Council was held at the Carlton in Lindrick Civic Centre, Long Lane, Carlton in Lindrick, Worksop, on Tuesday 9th April 2019.

115. PARISH COUNCIL ELECTIONS – 2ND MAY 2019

Members were informed by the Returning Officer that a Parish Council Election for Carlton in Lindrick will not be necessary following receipt of 10 nominations for 15 seats.

The Parish Council has also been informed that it will be in a position to co-opt any interested qualifying persons to the 5 vacancies after the 2nd May 2019.

117. PLANNING APPLICATIONS

19/00315/CAT – Land South of Carlton Hall Lane – T1 Horse chestnut reduce end load weight from the low large limb, reducing the end by carefully pruning back 4 meter and removing the branched from the underside of the primary limb – The Parish Council has no objections to this proposal

19/00318/COU – Annexe to Freshfields, Carton Road – Proposed change of use from an annex to spa facilities to work in conjunction with the existing spa on site – The Parish Council has no objections to this proposal

19/00336/RSB – Land adjacent to Warwick Avenue - Erect 4 detached dwellings with detached garages and construct new access (resubmission of PA 18/01450/FUL) – The Parish Council supports this proposal
