

Carlton in Lindrick Parish Council

The Annual Meeting of the Parish Council was held at the Civic Centre, Long Lane, Carlton in Lindrick, Worksop, on Tuesday 9th May 2017.

11. STREET DANCING PROJECT – CARLTON YOUTH CENTRE

Letters have been received from volunteers, parents and young people at the Centre who are receiving dance training with a view to participating in the Village Fete in July 2017. Details of the initiative were considered by members and it was
RESOLVED that a grant of £250 be approved in support of the group.

12. PROVISION OF FRIDAY NIGHT YOUTH SESSION

The Clerk referred to the withdrawal of funding previously received from the County Council for the provision of Youth Services at the Youth Centre on Friday evenings.

Although the County are continuing to provide and support services, current budgetary provision will mean that the Friday night session is to be cancelled.

Members were informed of the annual costings for continuing the session which are estimated by County Officers at £5,700 in total.

The session is attended by 60 to 80 young people with some parent and volunteer involvement. County Council Officers and Centre staff have indicated that the session can continue to be provided with financial support.

The Clerk reported that subscriptions and other income on Friday evening could raise £2,700 (approx.) leaving a deficit at the present level of support of £3,000 per annum. Members considered the importance of maintaining services at the Centre and the long term community benefits which result from securing facilities for young people in the Parish.

RESOLVED that

- 1) the report be noted
- 2) the Parish Council approve a grant of £3,000 for the continuance of the Friday night activity session at the Centre to be provided by Notts County Council Officers and Staff.
- 3) the approved funding be ring fenced for expenditure for one year only and the service be reviewed prior to the 2018/2019 financial year.
- 4) the Clerk be authorised to liaise with County Council Staff to ensure continuance of the current level of Youth Service.

13. PLANNING APPLICATIONS

17/00561/HSE – 7 Highfield Grove – The Parish Council has no objection to this proposal providing it is not considered to have an adverse effect on neighbouring properties.

17/00001/FUL – Breck House, Blyth Road the Parish Council wish to make the following observations:-

I have been requested to submit the Parish Council's "concerns" relating to this site.

You will be aware that extensive site clearance works have already been undertaken at this property including the "demolition" of trees and garden areas. A substantial boundary wall has been constructed at the front of the site and as a Council we are not aware of any planning permissions approved for that construction.

In addition the existing building on the site is described by the applicant as a derelict building but none of the Parish Council members have witnessed or been aware of any dereliction until the site was occupied by the current owner. There could be a view that the so called "dereliction" has been somewhat "manufactured" to justify the submission of the present application.

You will also be aware that the site occupies land which is adjacent to a recently approved application for touring caravan purposes and Parish Council members feel that the capacity of the current residential application may be seen as “lending” itself to conversion to business premises in the near future.

As a Council we are unsure that what might be described as “speculation” can be addressed but the scale of this proposal and development and the complete renovation of the site has led to concerns which we feel should be brought to your attention.
