6. GRASSCUTTING/GARDEN SERVICES

The Clerk reported that Acre Landscapes have commenced work in the Parish for the 2022/23 season. Footpath maintenance work will be undertaken during May 2022

7. WILDFLOWER AREAS

Further to discussion held by the Council on this issue the Clerk reported that County Councillor Callum Bailey had made some enquiries with County Officers on the potential for including some highway areas in the Parish. Gillian Shepherd has been informed.

8. MAINTENANCE CONTRACT 2023-2027

The Clerk is preparing the specification along with other documentation for the grasscutting and grounds maintenance Contract which includes maintenance of the Church burial grounds, Hundred Acre Lane Cemetery the Civic Centre grounds and the Youth Centre Grounds. The Council will be informed in due course of companies being invited to submit tenders.

9. WAYSIDER SEATING

Members were reminded that arrangements are in hand for Platinum Jubilee Commemorative seats to be located at Hundred Acre Lane and the Civic Centre Field in addition to the Christopher Trust and The Green Charity providing one at the Pond Area. In addition, a replacement seat is to be installed at Lambert Gardens.

10. TREE PROVISION

Councillor James De Villiers has a further 30 trees received from the Woodland Trust including silver birches which could create a feature at the Cemetery subject to discussion with other members.

RECOMMENDED that arrangements be made for a site meeting at the Cemetery.
