

FINANCE AND RISK ASSESSMENT SUB-COMMITTEE

A meeting of the Sub-Committee was held on the 28th November 2018.

Present: Councillors E. Banks, W. Murdoch and C. Smith.

10. BUDGET PROPOSAL – 2019/2020

Members had before them information on levels of income and expenditure with forecasts for the Council's financial activity to the financial year ending March 2019. A summary of projected anticipated balances for the years ending March 2019 and March 2020 were also circulated.

In addition, members considered the forecasted levels of income and expenditure for the financial year 1st April 2019 to 31st March 2020 under each of the Council's budget headings.

The Clerk brought attention to the management of capital expenditure on the new burial ground contract.

RECOMMENDED that 1) The schedules of financial information circulated be noted
2) the budget proposal for income and expenditure for 2019/2020 be approved and referred to full Council with a recommendation that the Parish Council Tax Precept Level remain at £95 for the financial year 2019/2020.

RECOMMENDED that

- 1) the provision of poppy's on lamp standards be continued annually
- 2) the Ramsden School Head, Staff and pupils be congratulated on the presentation of a moving tribute and service of commemoration and the Council support measures being considered to create a permanent memorial publication for those lost in action in the First World War.
- 3) consideration be given to the provision of public address facilities at the War Memorial for the Annual Community Service
- 4) Helen Brown and her staff be thanked for their support in securing the weekend arrangements.

8. ROAD SIGNS

RECOMMENDED that the County Council be thanked for the new HGV Advisory signs at Greenway and on Hundred Acre Lane.

9. NOTICE BOARDS

RECOMMENDED that 1) the existing boards be repaired
2) consideration be given to the location of new information notice boards at the library/shops in Long Land and the Beckett Avenue Post Office.
