FINANCE AND RISK ASSESSMENT SUB-COMMITTEE

A meeting of the Sub-Committee was held on the 27th November 2019.

Present: Councillor S. Jackson(Chairman), Councillors E. Banks and C. Smith.

Apologies for absence were received from Councillors L. Billau, V. Bowles, W. Murdoch and S. Scotthorne

Peter Goulding (Parish Clerk) was in attendance.

10. BUDGET 2020/21

The Clerk presented a financial report on current levels of income and expenditure which included projected balances for the financial year end March 2020.

In addition, a projected schedule of income and expenditure anticipated for the year April 2020 to March 2021 was circulated which included a projected balance for the year ending March 2021.

The Clerk clarified various items within the schedule and reported that at the present time the Councils financial forecasts would not require any variations in the current level of Council Tax Precept.

RECOMMENDED that:-

- 1) the Budget report for the financial year April 2020 to March 2021 be noted and approved.
- 2) the projected balances and reserves for the financial year end March 2020 be noted
- 3) the budget proposals for no change in the current Council Tax Precept of £95 per property be recommended for approval by the Parish Council

ENVIRONMENTAL WORKING PARTY

A meeting of the Working Party was held on 27th November 2019.

Apologies for absence were received from Councillors L. Billau, V. Bowles, C. Connolly and S. Walsh

11. HUNDRED ACRE LANE CEMETERY MAINTENANCE

The Clerk informed members that the maintenance work required at the new cemetery had been added to the current grounds maintenance contract and included in the Council's budget requirement to March 2021.

12. PLANNING APPLICATION 19/01189 - Colliers Butchers, Greenway

Members were made aware of the Refusal Notice in respect of the above application. The reasons for refusal included reference to the Neighbourhood Plan and to Highway Objections highlighted by the County Council and the Parish Council.

RECOMMENDED that 1) the decision be noted and welcomed

2) the Clerk be authorised to obtain information from the Bassetlaw Planning Department on the current "status" of the site in relation to any work which may have been undertaken which is contrary to the Decision Notice

13. PEPPERS DEVELOPMENT – BLYTH ROAD

The District Council is consulting the Parish Council on the identity of the new housing development which will be accessed from Thievesdale Lane, Worksop.

Although the site is within the Parish it has been suggested that a formal address as "Carlton in Lindrick" could cause confusion given the location of the site which is on the fringe of the Parished Area.

Members considered the current addresses applied to adjoining sites located in what is identified as the "Carlton Forest" area of the Parish and it was:-

RECOMMENDED that the formal address for the site be supported as "Carlton Forest".

14. COMMERCIAL PROPERTIES – HIGH ROAD

Following discussions at the last Parish Council Meeting the Clerk reported on correspondence with the District Council Conservation Officer. Members were informed that some progress has been made following discussion between the Officer and property owners.

15. DOUBLE YELLOW LINES – CHAPELGATE/LOW STREET

Councillor Bowles reported on a variety of issues raised with the County Council on both road maintenance and the status of double yellow lines at this location. The Clerk was requested to make further enquiries.

16. LAWN ROAD – DISPOSAL OF DRINKS CANS

It appears that occupiers of HGV's parking in the Lawn Road vicinity are depositing empty drinks cans into the street. The Clerk agreed to make enquiries.
