

FINANCE AND RISK ASSESSMENT SUB-COMMITTEE

A meeting of the Sub-Committee was held on the 26th September 2018.

7. RECEIPTS AND PAYMENTS 2018/19

Members had before them a schedule of Receipts and Payments for April to September 2018. RECOMMENDED that the Schedule be noted.

8. PUBLIC WORK LOAN BOARD – LOAN FACILITY

The Clerk informed members that the financial loan obtained to pay for the development of the new burial ground had been paid into the Parish Council's bank account today – 26th September 2018.

The loan is in the amount of £450,000 to be repaid over a 40 year period at a fixed rate interest of 2.94%. Repayments of £9,603 are to be made on two occasions each year the first payment to be made on the 26th March 2019 and the 26th September each year. A schedule of repayments has been received from the Public Works Loan Board and the final payment will be made on the 26th September 2058.

RECOMMENDED that the Council note and approve the report.

9. BUDGET PROCESS 2019/20

The Clerk reminded members that the budget process for the 2019/20 financial year will commence during November/December 2018.

ENVIRONMENTAL WORKING PARTY

2. KING GEORGE V PLANYING FIELD - FOOTBALL

The Clerk reminded members that the pitch was now being used by a junior football team and a team of senior players. Complaints are now being made relating to car parking difficulties, the blocking of the highway which could potentially have serious consequences for emergency vehicles and the conflict of regulations now being implemented by Sheffield & Hallamshire Football Association on the use of pitches by juniors. Reference to the parking problems has recently been made at a meeting of the Christopher Johnson Trust & The Green Charity meeting. Members were aware that during the two previous football seasons the pitch had been used without any complaints being registered.

RECOMMENDED that the use of the pitch by the Sherwood Ranger Football team be terminated at the appropriate time and the Clerk continue to liaise with Bassetlaw District Council on their use of a pitch at Costhorpe to fulfil their fixtures.

4. BASSETLAW DISTRICT COUNCIL – PILGRIM FATHERS – HERITAGE LOTTERY FUNDING
