

## Carlton in Lindrick Parish Council

A meeting of the Parish Council was held at Carlton Civic Centre, Long Lane, Carlton in Lindrick, Worksop, on Tuesday 8<sup>th</sup> November 2022.

Apologies for absence were received from Councillor L. Billau, and District Councillor D. Pidwell.

County Councillor C. Bailey, District Councillor R. Carrington-Wilde and Peter Goulding (Parish Clerk) were in attendance

Prior to commencement of Council's official business, the Chairman announced that in accordance with the Openness of Local Government Bodies Regulations, audio/visual recording and photography at Council meetings is permitted in accordance with the Council's protocol "Filming of Public Meetings". The Chairman asked if anyone present intended to record proceedings.

### 98. MINUTES

RESOLVED that

- 1) the minutes of the meeting held on the 11<sup>th</sup> October 2022 be approved
- 2) the discussion on work being undertaken at the Sherwood Ranger and activities relating to the Conservation Officer and the Planning Department be noted.

### 99. NOTTS COUNTY COUNCIL ISSUES

#### a) Speed Limit – Blyth Road

Members were circulated with a further letter from the Clerk to the County Council expressing concerns at the speed of traffic using Hundred Acre Lane and the increase in volume of traffic at the Greenway junction with the A60 Highway. The Parish Council has been advised that the consultation had been in relation to proposals for Blyth Road at the current time and did not include any proposals or consideration of traffic using Hundred Acre Lane.

RESOLVED that the County Council be further requested to monitor the speed and volume of traffic accessing the A60 via Hundred Acre Lane and Greenway and the Parish Council's continuing concerns be reiterated.

#### b) School buses

Further discussion took place on the monitoring of school bus provision and the inadequacy of school place provision resulting in unsatisfactory services for families in the Parish.

County Councillor Bailey explained the current systems and procedures being applied by the County on a County wide basis. Councillor Bailey also agreed to discuss a particular problem for a family resident in the village highlighted by Councillor Croot.

c) Other Issues

Councillor Bailey reported on improved highway maintenance work undertaken in the village on various pot-hole problems and on yellow hatching work at the A60/Greenway junction.

**100. BASSETLAW DISTRICT COUNCIL ISSUES**

Councillor Wilde referred to previous discussions and reminded members of proposals for additional educational places along with other community services for areas in, and adjacent to, the northern part of Worksop. Councillor Wilde also referred to the work of the Environmental Enforcement Team undertaking patrols in the district. Reference was also made to the forthcoming issues faced by families affected by the forecasted 'cost of living crisis' underpinned by excessive fuel costs and increased prices for essentials including food.

Councillor Jackson reported on current supportive activities taking place at the Youth Centre and the Clerk agreed to liaise with supporting organisations taking measures to stimulate further help from the much appreciated voluntary sector.

Councillor Scotthorne reported on District Council's future Housing Investment and measures being adopted for increased community support. Councillor Wilde reminded members of individual financial grant aid available from District and County Members.
